

AGNITY Public End-User License Agreement

NOTE: A SOURCE CODE VERSION OF THE AGNITY SOFTWARE LICENSED HEREUNDER THAT YOU MAY COPY, MODIFY, COMPILE, EXECUTE, AND DISTRIBUTE IS AVAILABLE TO YOU FREE-OF-CHARGE FROM WWW.AGNITY.COM UNDER THE AGNITY PUBLIC LICENSE (“APL”), and other open source software licenses.

The accompanying executable code version of AGNITY SOFTWARE (the “Product”) is made available to you under the terms of this AGNITY PUBLIC END-USER LICENSE AGREEMENT (THE “AGREEMENT”). BY CLICKING THE “ACCEPT” BUTTON, OR BY INSTALLING OR USING THE PRODUCT, YOU ARE CONSENTING TO BE BOUND BY THE AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT, DO NOT CLICK THE “ACCEPT” BUTTON, AND DO NOT INSTALL OR USE ANY PART OF THE PRODUCT.

1. COPYRIGHT LICENSE -- USE. AGNITY, Inc. (“AGNITY”) grants you, under any and all of its copyright interest in and to the Product, a royalty-free, non exclusive license to copy and execute the executable code version of the Product. This Agreement will also govern any software upgrades provided by AGNITY that replace and/or supplement the original Product, unless such upgrades are accompanied by a separate license, in which case the terms of that license will govern. For avoidance of doubt, AGNITY is not obligated to provide you with any support, bug fixes, upgrades, or updates to the Product.
2. COPYRIGHT LICENSE -- DISTRIBUTION. AGNITY hereby grants you, under any and all of its copyright interest in and to the Product, a royalty-free, non-exclusive license to copy and distribute unmodified copies of the Product, provided that: (a) you ensure that each copy is provided using a technical means (such as an installation program) that requires each recipient to agree to the terms of this Agreement prior to receiving or installing such copy; (b) you include a complete copy of this Agreement with each copy; (c) in any copy of the Product you make, you must retain and reproduce any and all copyright, patent, trademark, and attribution notices that are included in the Product in the same form as they appear in the Product, including without limitation the preservation of attribution notices in the form of trademarks or logos that exist within a user interface of the Product; and (d) you do not make any representations or warranties on behalf of AGNITY or its suppliers or licensors. For avoidance of doubt, the license granted to you in Paragraph 1 is not sublicenseable; any recipient of a copy of the Product provided by

you under this Paragraph 2 receives a license directly from AGNITY as described in Paragraph 1.

3. **PROPRIETARY RIGHTS.** Portions of the Product are available in source code form under the terms of APL or other open source licenses (collectively, “Open Source Licenses”) at www.AGNITY.com. Nothing in this Agreement will be construed to limit any rights granted under the Open Source Licenses. Except for the licenses expressly granted under copyright in Paragraphs 1 and 2, no rights, licenses or forbearances are granted or may arise in relation to this Agreement whether expressly, by implication, exhaustion, estoppel or otherwise. All rights, including all intellectual property rights, that are not expressly granted under this Agreement are hereby reserved. You may not remove or alter any trademark, logo, copyright or other proprietary notice in or on the Product. You may not modify, alter or tamper in any way with the Product (if you desire to make modifications to the Product, please instead use the source code version under the appropriate Open Source Licenses). This Agreement does not grant you any right to use the trademarks, service marks or logos of AGNITY or its licensors, except as necessary to fulfill the conditions of Paragraph 2.
4. **TERMINATION.** If you breach this Agreement, the licenses granted to you under this Agreement will terminate immediately and without notice, but all provisions of this Agreement except the license grants in Paragraphs 1 and 2 will survive termination and continue in effect. Upon termination, you must destroy all copies of the Product in your possession or control.
5. **DISCLAIMER OF WARRANTY. THE PRODUCT IS PROVIDED “AS IS” AND WITHOUT WARRANTY OF ANY KIND. AGNITY MAKES NO WARRANTIES, WHETHER EXPRESS, IMPLIED, OR STATUTORY REGARDING OR RELATING TO THE PRODUCT. 7. EXPORT CONTROLS. This license is subject to all applicable export restrictions. You must comply with all export and import laws and restrictions and regulations of any United States or foreign agency or authority relating to the Product and its use.

(d) If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties’ original intent, and the remaining portions will remain in full force and effect. (e) A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. (f) Except as required by law, the controlling language of this Agreement is English. (g) You may not assign your rights under this Agreement to any party without the prior written consent of AGNITY; AGNITY may assign its rights under this Agreement without condition. (h) This Agreement will be binding upon and inure to the benefit of the parties, their successors and permitted assigns.
